Creditors and persons who have claims in relation to assets held by the company, are invited to register their claims and proof thereof within the above mentioned deadline with the bankruptcy liquidator.

Debtors of the company and persons who have taken possession of the company's assets through a pledge of for any other reason must report to the bankruptcy liquidator within the deadline reported above. Any existing pre-emptive right lapses in the event of an unjustifiable failure to report a surrender.

Creditors domiciled or residing outside of Switzerland are required to appoint an authorised person for service in Switzerland until June 29, 2015. If no such address is provided, the premises of the bankruptcy liquidator are deemed to be the place for service.
